Treasurer's Report August

- 3 Archery Club-Landscape for run off away from building, Bathrooms, Fridge, Microwave?, Baseboard, Floor. No Change**
- 4 Concrete culvert under lower trail North of dike installation. No Change**
- 5 Gahm Enterprises Fundraiser. No Change**
- 6 Grants for bathroom remodeling at Archery Clubhouse. No Change, Dave Lockhart still trying to contact Vanessa Wessels at Sauk Valley Bank by County Market**
- 7 Dallan Jones report on 3D targets. Priced out inserts needed at \$1900, possibly leave out the Velociraptor @ \$133-could sell a Skunk, Turkey, Antelope, Deer & Coyote to help with paying for inserts. Dave Lockhart made motion to auction 5 3D targets after the 815 Bowhunters 3D shoot and table inserts until next meeting, Paula Adams 2nd, Motion Adopted**
- 8 Waiver for 3D shoots. Kent Bushman worked up a Waiver and Assumption of Risk for 3D shoots after reviewing many examples. Dallan Jones made motion to adopt, Rob Miller 2nd, Motion Adopted**
- 9 Signs for Archery Range to spread your shots out. Use center for initially sighting in. Paula Adams made signs and Dallan Jones installed them.**
- 10 Haunted hay rack ride mid October? Paula Adams talked to a few businesses that would be interested in setting something up on the trail. Dallan Jones said if did Trunk or Treat in parking lot Sterling Walmart would participate. Charge would only be for the Haunted Hay Rack Ride. Date would be 10/18 or 10/17&18. Cost would be food and drink to be sold in Club House. Chris McCauley made motion to move forward with planning, Gary Linton 2nd, Motion Adopted.**
- 11 Dave Lockhart mentioned the Port a Pot lock is closed and won't open. He left a message that it needed fixed. It has been taken care of.**
- 12 Some wires up a pole need replaced. Kent Bushman spoke with Jon Bush owner of JB Electric and he wasn't concerned as long as no breakers were being kicked out. Kent Bushman inspected on 7/22 and found no bare wires to tape up.**
- 13 Air freshener needed in ladies rest room at Archery club. Think this was just a case of the door not being left open after an event and getting stale smelling.**
- 14 P trap on men's urinal needs replaced. Dave Lockhart replaced it.**

New Business

1 Gate keys will be at Trap Club house in case electric goes out on gates and they need to be opened manually.

2 Mowers, Dave Lockhart mentioned the Dixon's are getting old, hard to find parts and breaking down frequently. Looking for a spare he found a couple Simplicitys, one was a 2021 with 38 hours at Wilco but a private sale so no tax. Kent Bushman knew the owner and called him and he would sell and deliver to Club for \$4200. Steve Grace made motion to purchase, Dave Lockhart 2nd, Motion Adopted

3 Targets ordered 6/18 for July delivery. Kent got call that they wouldn't be here until end of August or September. Lawry said tariffs were messing things up. Think clubs in Canada that were throwing White Flyer switched to Lawry and he's now overwhelmed with orders. Doing some checking with Tri-County and Paula is going to contact Tractor Supply in Morrison.

4 Kent Bushman was told by one of the Skeet shooters that the walkway needed some repairs. Dave Lockhart inspected and came up with list of material for \$436 + tax. Need to find someone to do the work. Kent will talk to Skeet shooters and if that don't work Paula will reach out to all members asking for 4 or

5 volunteers. Dave Lockhart made motion to allow \$600 for material for Skeet walkway repair, Gary Linton 2nd, Motion Adopted
